1. Welcome:

Cllr Bedson opened the meeting and welcomed councillors and member of the public.

2. Apologies: Cllr. Adrian Felton, Cllr. Phil Woodward, Cllr. Jane Shufflebotham and Cllr Joe Porter (Parish and District).

3. Declaration of Interests:

Cllr. Hunt – Carnival and Lunch Club

Cllr Berrisford – The Bush

4. Public Participation: No questions were raised.

5. PCSO Report: A report about changes to PCSO working hours restricting attendance was noted. Clerk to contact PCSO Josh Hargreaves to ask for a report for September.

6. County Council Report: Cllr. Egginton

- **Community Fund:** A donation from The County Community Fund has been approved for the Brown Edge Well Dressing Committee - it was noted that over 2000 people attended the Carnival. Funding has also been approved for the Anniversary Lunch event at Brown Edge Lunch Club.
- **Grit Bins:** A Grit Bin statement is being produced – all bins need to be logged as some are not on the system. Areas where there is no bin need to be noted and applied for. The piles of grit are not working and wasting grit. The circular pipes with grit in do work as they are larger. Empty grit bins have been stolen.
- **Highways Inspections:** The Highways department are experimenting with AI for inspections of Highways. A camera is fastened to a vehicle can identify potholes and other problems. it is only an experiment and will not be launched until it is tested.
- **Public Rights of Way (PROW):** A question was asked by Cllr. Jebb about registration of informal paths through Tinster's Wood. Cllr. Egginton reported that there are 260 cases of PROW issues backlogged. More funding and more officers are required in that department.

7. District Councillors Report:

- **Local Improvement Framework (LIF)** A new grant opportunity is available for Health, Wellbeing and Community focused projects.

- **My Active Leek** – The refurbished Leisure Centre at Brough Park will open on 15th August to existing members, then will open to the public on 18th
- **Brown Bins:** A meeting has been held with officers to solve initial problems reported with the new food waste collections and brown bin garden waste collections.
- **Planning:** A question was asked to Cllr. Flunder to clarify the special measures in force with Planning at SMDC. Cllr. Funder stated that he can only advise on procedural matters. The main change is that members cannot request for applications to go to Planning Committee. The Planning Committee date is set for 10th September for the Land off Breach Road application.

The Council decided that Cllr. Berrisford would liaise between the Lengthsman and the Allotment Association to come to an agreement on communication to move the mole hill soil before mowing commences.

- b) Local Government Reorganisation:** Cllr Bedson and Oberholster attended a workshop about the Mutual Ventures consultation. Cllr. Flunder in the role of Community Champion has supported Cllr. Oberholster to complete the survey. Cllr Oberholster was thanked for writing the report on behalf of Brown Edge Parish Council.

Cllr. Egginton had proposed a poll to gauge public opinion on LGR as he felt a strategic review of the process could go to judicial review if there was enough objection.

The Clerk advised that it was not lawful for a Parish to organise a poll on social media.

- c) Parish Council meeting length:** Cllr. Bedson moved to cut down the time of meetings to a maximum of 9:30pm.

11. Project Reports:

- a) **New Cemetery Field: An Ecology report has now been received.** Clerk to file all the reports and to circulate the maps and deeds for discussion at the September meeting. Cllr. Berrisford reported that the Planning application will now be drafted by the Architects.

- b) **Restoration of Community Phone Box:** The application to the Moorlands Partnership Board was successful. The MPB awarded 75% of the cost (capped at £3,218.00) to be claimed after project completion. Clerk to meet with volunteers to discuss requirements before placing the order.

The Council approved to contribute 25% (approximately) to the project to be vied from the Staff budget.

Cllr. Eggerton suggested to apply to his Community Fund for the Groundwork costs.

- c) **Sandy Lane Centre:** An application to have the Sandy Lane Centre registered as an Asset of Community Value has been submitted to SMDC.

- d) **Playground Maintenance:** The Rospa inspection will be done in August. Item to be on the September agenda for any maintenance to be actioned.

The Clerk presented a quotation from Broxap for Playing Field Bins from the County Council earmarked grants.

- e) **New Street Lamp for Thelma Avenue:** The Severn Trent funding has not yet been received. ***Cllr. Porter to be asked to follow this up.***

- f) **Nature in Your Neighbourhood:** Proof of the land being registered by Brown Edge Parish Council was circulated and has been submitted to Staffordshire Wildlife Trust so that the project can proceed. ***Awaiting approval*** from SWT.

Clerk to make the other title deed documents digital.

- g) **SMDC Rural Fund:**

The Council approved to apply for a plinth to be built to surround the flagpole.

- h) **Brown Edge Action Group:**

It was agreed to ask Support Staffordshire to help the Council set up a constituted group so that the Pump track idea can be progressed and grants can be applied for.

- i) **Burnt Tree in the Playing Field:** Cllr. Bedson has negotiated with the Insurance company to get the full cost of the tree removal covered. N & J Tree Services will be completing the work on 21st September.
- j) **Adverse Possession** Cllr Berrisford moved to apply for the verge adjacent to Sytch Well.
Clerk to pursue with Cllr Egginton and County Officers to progress this claim.

Appendix 1: REPORT: District Councillor Christina Jebb

Local Improvement Framework grants are now available offering up to £1,500 to support community led projects that make a positive difference to health and wellbeing in Staffordshire Moorlands. The deadline is 9am Tuesday 1st September

MyActive Leek preview event for members on 15th August to thank them for their patience during the renovations and to give them an opportunity to try out some of the facilities, ahead of the public opening on the 18th. The aim of this part of the day is to reward loyal members for their patience during the redevelopment and enable the team to test the operation of the centre.

The centre has undergone a £17 million redevelopment project to modernise and expand the building and install an outdoor Active Zone to create a health and wellbeing centre, that will support the physical and mental health of residents across the Staffordshire Moorlands for many years to come.

Protecting public spaces from dog fouling

With dog fouling in public spaces continuing to be an issue across the Moorlands, the District Council is considering introducing a Public Spaces Protection Order (PSPO) and is now inviting residents, businesses and stakeholders to share their views.

Dog fouling can spoil the enjoyment and appearance of public places including footpaths, parks, recreational areas and other open spaces. The proposed PSPO would help promote responsible dog ownership and provide enforcement powers where dog owners fail to remove dog mess from public areas. Most dog owners do behave responsibly. The consultation is now open and there are full details, including how to respond, on the SMDC website. The closing date is 23 August. Anyone unable to complete the online response form can request a paper copy from Customer Services staff on Council receptions.

SMDC Licensing Policy

Staffordshire Moorlands District Council are also consulting upon their Statement of Licensing Policy under the Licensing Act 2003. This happens every 5 years and anyone can respond if they feel that it is relevant. The consultation period ends on 30 September 2026. Comments should be e-mailed to:-

Appendix 2. REPORT - District Councillor Keith Flunder:

1.LGR Update and summary: -

a)The Government have announced that the Staffordshire Moorlands District Council Area will be part of the new North Staffordshire Unitary Council area including Newcastle-under-Lyme Borough Council area and Stoke City Council Unitary area. This will only give 9 months to arrange the election of the new authorities roughly based on the old County Council divisions.

b)The next stage in the SMDC district Locality Plan preparation is the closing of the initial consultation period (this has been extended to Wed. August 5th at my request. This will allow Endon, Brown Edge and Bagnall parish councils to submit their responses to Mutual Venture. There is still quite a lot of work to do including the arranging of three themed face to face meetings.

c)Another champions meeting will be held before the final three separate subject lead meetings, to ensure that Health and wellbeing is included for public sector organisations, tourism & culture and re-generation / infrastructure (transport) will also be included.

d)Parish and Town councils then need to log both their physical assets and community groups and activities. These will include public areas and street furniture etc. It is hoped that this process will help them look at their own assets and support their own local strategic plans, which can be completed in detail before March 2027.

e)Future meetings and possible visits to parishes are also available. Although it might be best to get a report on the agenda from the planned locality meetings..

f)I'm still hopeful that there will be some assistance from SMDC, as to the best way to transfer any community assets in the remaining time period.

2.The Parish Assembly and the SPCA will support Parish and Town councils over the coming years to produce their own plans. This was agreed at the recent SPCA executive meetings in Stafford. The SPCA executive meeting was held on Monday 15th of June.

3.I was asked to report back to the Parish Council about the UKSPF projects that the District Council are currently completing. I will be receiving more information through the Services Delivery committee by the autumn and attending an opening day event.

4.MyActive Leek Leisure Centre is opening in August and The Nicholson Institute project (£3.2 Million) is now on-going with the library now operating on the ground floor of Moorlands House, until the building is ready to be moved back into. This is due for completion later in the year (possibly early 2027?). There has also been more UKSPF funding made available (just under £1 million) for other projects around the Staffordshire Moorlands partly related to Arts and Culture.

5.Brown Bin charges started from June 29th 2026, for residents in the SMDC district. Residents need to register as soon as possible if they want their bin to still be collected. The food bin service has received complaints, and the services team are contacting the local residents who have had issues. A meeting with the officers and cabinet members concerned has resulted in more awareness of the issues across Brown Edge and Endon.

6.The Green Space maps have been delivered to Brown Edge councillors.

7.Other local projects I'm currently looking into, include playgrounds / cycle/skate parks and parking areas to support local activities and community projects.

8. Planning: The District Council has been placed in 'special measures', meaning applicants for larger applications can now go directly to the national Planning Inspectorate if they wish. SMDC officers are looking at how these measures can be lifted as soon as possible. The next Planning Committee meeting is on August 13th. I have been lobbied about the application for development along Breech Lane, and an enforcement notice is currently being appealed.

9. The CIF (Councillor Initiative Fund) has now been reopened for 2026/27.

10. Other future and recent meetings attended include a street furniture working group meeting, a film about climate emergency at Endon Village Hall and local LGR meetings.

11. Councillor Surgeries planned in Aug. and Sept, dates to be promoted. The surgery meeting on Sat. 31st had residents raising concerns about the planning issues along Breech Road and road side clearance.

PROTECTING OUR RURAL COMMUNITIES AND PEAK DISTRICT LANDSCAPE

I was pleased to recently attend an excellent public meeting and drop-in event organised by Action Against CCS and NO to Peak Cluster CO₂ Pipeline Staffordshire Moorlands & Leek, where I had the opportunity to hear directly from local residents, local farmers and campaigners about their concerns regarding the proposed Peak Cluster project.

Following productive discussions with the campaign and members of the local community, I remain deeply concerned about the potential impact this scheme could have on the Staffordshire Moorlands, the Peak District, our local villages, prime agricultural land and valuable wildlife habitats.

The Peak Cluster proposal would involve a major CO₂ pipeline network running across large areas of countryside, farmland and rural communities, together with associated above-ground infrastructure. Campaigners have raised serious concerns about the potential impact on protected landscapes, wildlife corridors, farmland and the character of our local villages.

The Peak District is one of our nation's most treasured landscapes. As someone with a deep passion for the Peak District and a long-standing commitment to protecting nature and our environment, I believe we have a duty to safeguard this unique landscape for future generations, not risk further industrialisation of our countryside.

I am also concerned by the track record of large-scale national infrastructure projects. Too often they end up over budget, years behind schedule and leave local communities dealing with the

consequences. Questions have also been raised about the scale of public funding and subsidy associated with the project, with many residents asking whether there are better ways to invest in environmental improvements and emissions reduction.

While I support sensible action to tackle climate change and reduce emissions, that should not come at the expense of our landscapes, farming communities, local nature and rural way of life.

I will continue standing up for our villages, our farmers, our countryside and our local environment.

PUBLIC MEETING ON PROPOSED 55 HOMES

A really well-attended public meeting, hosted by Brown Edge Parish Council, discussed planning application SMD/2026/0201 for up to 55 homes off Breach Road, Brown Edge.

Local residents asked plenty of thoughtful and important questions of the developers, particularly about the Green Belt, road safety, flooding and drainage concerns, and the potential impact on our village.

Thank you to the developers for attending and taking questions from local residents. However, many people left disappointed that the serious concerns raised about road safety were not addressed at all.

It was clear that those attending were overwhelmingly opposed to the application, with many expressing significant concerns about the proposal and its impact on Brown Edge.

Thank you to everyone who attended. The passion and commitment to our community was clear to see.

TONGUE LANE FLY-TIPPING REMOVED

The fly-tipping on Tongue Lane, Brown Edge has been removed by the Staffordshire Moorlands District Council environmental crime team within a few days of it being reported. Thank you to all those who reported to me. I will be asking for our rural country lanes to be regularly monitored for fly-tipping.
